


The regular meeting of the Board of County Commissioners was brought to order by Commissioner William J. Novotny, III at 3:00pm on Tuesday January 3, 2023. Attending were Commissioners Jeff Shelley and Robert Perry, Commissioner's Assistant Jody Telkamp, County Attorney Tucker Ruby, and County Clerk Jackie Camino.

Perry moved to approve the minutes of the December 06, 2022, regular meeting. Shelley seconded; motion carried.

Election of County Commissioner Officers for 2023; Perry moved that William Novotny III be re-appointed as Chairman. Shelley seconded: motion carried. Commissioner Shelley moved and Chairman Novotny seconded to appoint Commissioner Perry as Vice-Chairman of the County Commissioners for 2023. Motion carried.

Weed & Pest District: Commissioner Perry moved to re-appoint Dick Gould. Commissioner Shelley seconded. Motion carried. Tyler Benton could not be reappointed as his application for reappointment was missing documentation. His appointment deferred to the next meeting.

Boundary Line Adjustment - Since not all property owners had signed the required documentation, the boundary adjustment has been removed from this month's agenda to be considered at a future Commissioners' meeting.

Mike Madden presented discussion to Board of Commissioners regarding the Tourism Board and recommended changes to the By-Laws to amend the number of board members that should be on the board with the idea a smaller board would be more efficient. Clerk to research the 1999 amendment and the matter will be revisited

Budget Hearing: Commissioner Perry moved to approve Resolution 694 as read by Chairman Novotny which allows additional funds of \$24,875.30 to the budget. Motion was seconded by Commissioner Shelley. Chairman Novotny called for any public comment and there was none. Motion carried.

Commissioner Jeff Shelley moved that we waive the hiring freeze to accommodate the Clerk and Assessor offices to fill positions vacated when deputy clerks moved into the Clerk and Assessor positions. Commissioner Perry seconded and the motion Carried. Additionally Steve Rzasa, current director who has resigned his position presented a request to replace the childrens librarian vacated when Lindsey Belliveau was named to replace him as director. Commissioner Perry moved to waive the hiring freeze to replace the children's librarian, Commissioner Shelley seconded, motion carried.

Chairman Novotny discussed the need to ratify his signature on a contract for the Hazelton Seasonal Winter Parking Area for a seasonal permit. Commissioner Perry moved to ratify Novotny's signature, Shelley seconded. Motion carried.

Commissioner Shelley made a motion to grant the request by Taylor's Invasion Bar for a temporary catering permit for the event January 28th at the Fairgrounds annual fundraiser. Clerk confirmed approval letter is in order from the Town of Kaycee and all fees paid. Shelley moved to approve permit, Perry seconded and motion carried.

Commissioner Perry moved to grant the request and allow Chairman Novotny to sign the letter allowing the Cowboy Bar to temporarily transfer their liquor license into the city for an event at Bomber Mountain Civic Center on January third. Shelley seconded, motion carried.

Commissioner Perry moved to approve the December vouchers in the amount of \$510,741.09. Shelley seconded: motion carried.

Commissioner Shelley moved to re-appoint Thomas Camino as the Fire Warden and Scott Duncan as the Deputy Fire Warden. Perry seconded and motion carried.



The regular meeting of the Board of County Commissioners was brought to order by Commissioner William J Novotny, III at 9:00am on Tuesday February 7, 2023. Attending were Commissioners Jeff Shelley and Robert Perry, Commissioner's Assistant Jody Telkamp, County Attorney Tucker Ruby, and County Clerk Jackie Camino.

Perry moved to approve the minutes of the January 03, 2023, regular meeting. Shelley seconded; motion carried.

Commissioner Novotny convened the public hearing pertaining to the annual renewal of county liquor licenses. Renewals presented for approval were: MC Harper LLC dba Cowboy Bar & Grill, Johnson County Moose Lodge #2675, TA Ranch, Inc, Cattleguard Steakhouse LLC, Lake Stop LLC, South Fork Mountain Resort dba South Fork Inn, Paradise Ranch Co dba Paradise Guest Ranch, Good 2 Go Stores, LLC dba Good 2 Go Store #13, Est LLC dba Folded Hills Ranch, HF Bar Ranch Inc. dba HF Bar Ranch. Commissioner Novotny asked if all applications were in order and all fees paid. Clerk Camino responded that all but the Moose Lodge and TA Ranch, Inc were in order. She asked that all be approved but those two licenses and have those be held over for consideration at the next Commissioners meeting. There was no public comment. Jeff Shelley moved to approve all the licenses except the two with missing documentation. Bob Perry seconded and the motion carried. County Attorney Ruby explained the process should the two remaining outstanding licenses not get their paperwork in order.
